

**Rig Brite** will not streak or stain when used as directed. It can be used through spray and foam equipment fitted with an acid injector. It can also be used in a two step truck washing system along with a suitable truck wash.

Dilute 1 part with 8 to 32 parts water. Dilution may vary depending on specific application.

1. Apply diluted solution to trailer starting from the bottom and moving to the top in small sections to avoid streaking.
  2. Allow NO more than 2 minutes of contact time. Do NOT allow solution to dry on the surface.
  3. Rinse starting at the top and moving to the bottom to avoid streaking.
- Brushing may be necessary to remove heavy diesel exhaust deposits.
- Do NOT apply this product to glass surfaces.
